- Be an Adams County Farm Bureau member, spouse of a member or child of a member for a minimum of 1 year
- Be accepted for enrollment or be enrolled at a post-secondary school
- Exhibit potential for successful completion of course of study and be a full-time student
- Be a resident of Illinois
- Not be a spouse, child, sibling, grandchild, son-in-law, or daughter-in-law of an Adams County Farm Bureau Foundation Board member or employee

The criteria for awarding the scholarship are as follows:

- Scholarship
 - Academic performance and honors
 - Rank in Class
 - ACT Score
- Demonstrated interest in agriculture or related field
- Financial Need
- Evidence of self-help. How is the student contributing financially to his/her education?
- Character and personality
 - Maturity
 - Industriousness and motivation
 - Intellectual interest
 - Moral character
 - Demonstrated leadership
